The Contract, Bonds, and other documents requested by the Letter of Intent to Award have been received. These documents are accepted and approved. You are hereby awarded the contract in the amount of **\$6,448,530.00**. This amount is for the **Basic Bid** and includes the following work:

Replace the Noyes Slough Bridge #0209 on Aurora Drive in Fairbanks. Project work includes bridge work, roadside hardware, drainage improvements, intersection improvements, ADA improvements and utility work.

The betterments include replacement of water lines under Aurora Drive between Bridgewater and Cottonwood Street with tie-ins to adjacent streets.

Your conformed copies of the contract are enclosed. The contract completion date is **DECEMBER 31, 2023**.

A copy of the list of subcontractors you submitted for this project is included in the conformed copy. Please be advised that Section 103-1.02 of the Standard Specifications, and AS 36.30.115 prohibits the use of additional subcontractors by the Prime Contractor unless approved by the Contracting Officer. Replacement of any of the listed subcontractors is also prohibited unless the specific contract criteria have been met.

Good Faith Effort (GFE) Documentation was submitted to the Civil Rights Office.

A Notice of Work (NOW) and payment of associated fees must be made to the Alaska Department of Labor and Workforce Development (DOLWD) BEFORE a Notice to Proceed (NTP) will be issued by Department of Transportation & Public Facilities (DOT&PF). The Contractor must provide DOT&PF a copy of the NOW form stamped as received by DOLWD before a NTP will be issued.
